
Revisions to State Delisting Guidance Document

- Ohio RAP Coordinators are revising the state delisting guidance document and some changes are expected
- Guidelines were developed in 2004 and last revised in 2008
- Revisions could affect our AOC and the ability to delist
- Would like to make revisions that are more customized to Ohio Lake Erie tributary rivers
- Changes are expected for the following BUIs:
 - BUI 1 Fish Consumption: explore better method for determining background levels of PCBs and mercury in fish tissue
 - BUI 4 Fish Tumors: tumor and external anomalies study started in 2012 in Black, Cuyahoga, and Maumee AOCs, which could affect bullhead liver tumors delisting target
 - o BUI 8 Eutrophication/Undesirable Algae: information on harmful algal blooms will be added
 - \circ $\;$ BUI 10 Beach Closings: in discussion and changes unknown at this time $\;$
 - o BUI 11 Aesthetics: in discussion and changes unknown at this time
 - BUI 14 Fish and Wildlife Habitat: for fish, in discussion and changes unknown at this time; for wildlife, agricultural land matrix could be added to determine land use and habitat quality
- More information to follow on this document as discussion continue

Preliminary Results of 2012 Summer Sampling

- Comprehensive sampling was conducted in the Black River watershed with the hope of using the data
- Sampling included about 89 different sites and included:
 - o 82 passes for fish populations
 - 536 samples for inorganic analyses
 - 23 samples for organic analyses
 - 20 fish tissues samples
 - o 68 samples for bacteria
 - o 4 samples for sediment
- The hope is data gained from the sampling can be used to delist BUIs in the watershed
- NOTE: This is preliminary data, and although some improvements are suggested, any changes in BUI status anywhere in the AOC will not be discussed until final data are published by Ohio EPA
 - o BUI 1 Fish Consumption: No data available yet
 - BUI 2 Tainting: Not impaired in our AOC
 - BUI 3 Fish Populations:
 - West Branch, including Plum Creek, Charlemont Creek, and Wellington Creek, remains impaired and requires additional sampling.
 - Preliminary data is good enough to delist in all of the Main Stem and East Branch. Over time, the fish populations in the lower main stem have improved dramatically, as seen by the following charts:

Temporal Improvements Seen in the Fish Population Scores in the Lower Black River



- o BUI 4 Fish Tumors: Study is not complete
- o BUI 5 Bird or Animal Deformities: Not impaired in our AOC
- o BUI 6 Benthos: No data available yet
- BUI 7 Dredging: Not included in 2012 summer study; next sampling from Army Corps of Engineers is due in the next year or so
- BUI 8 Eutrophication/Undesirable Algae:
 - Eutrophication: dissolved oxygen levels meet delisting criteria throughout AOC
 - Algae: upgrades to the Grafton WWTP and Findley Lake WWTP plus removal of the dam at Brentwood Lake may have removed the problem throughout the AOC
- o BUI 9 Drinking Water: Not impaired in our AOC
- BUI 10 Recreational Use: No areas in AOC currently meet delisting criteria, but revisions of state delisting guidance document could affect status of BUI
- BUI 11 Aesthetics: Suspended solids in river/stream waters meet delisting criteria; unknown of other criteria is being met
- o BUI 12 Increased Cost of Agriculture or Industry: Not impaired in our AOC
- o BUI 13 Phyto and Zooplankton: Not impaired in our AOC
- BUI 14 Fish and Wildlife Habitat:
 - Fish Habitat: French Creek meets In Recovery designation; all upstream areas of lacustuary meet delisting target; lacustuary remains impaired
 - Wildlife Habitat: Not included in 2012 summer study, but revisions of state delisting guidance document could affect status of BUI

RAP Chairmanship

- Ken Pearce retired from LCGHD in August 2012
- Need to decide who will take over as RAP Chairman
- Ted agreed to run meetings in the interim, but his duties cannot extend beyond that
- If letters of support, etc. are needed, the Lorain County General Health District (LCGHD), as the RAP secretariat, will sign them
- If RAP matters are shared via email and require a vote or discussion, it is requested that you "Reply All" so all members receive the information
- We will continue to discuss this matter

Old Business

Use of EPA Pass-Through Grant Funds

Black River RAP Video

- A new video will be created to highlight the restoration work completed on the lower Black River
- We will begin discussions with the scriptwriter used in previous videos, Gay Eyerman, and video production at Lorain County Community College to see if they are interested in participating

Interns for Home Sewage Treatment System Inventory

- LCGHD brought up the possibility of using grant money to hire interns to complete an inventory of home sewage treatment systems (HSTS) in our county and better identify areas of potential contamination from failing HSTSs
- Would need to get approval from EPA central office to use funds in this manner
- LCGHD will draft a proposal to send to EPA

Retirements

- Need to get plaques made for members who retired in 2012 (Jim Boddy, Ken Pearce)
- LCGHD will contact the business and get these made
- Plaques will be presented at the July 2013 RAP meeting

New Business

Delisting of AOC

- There has been a huge push for all AOCs to delist
- Ted Conlin explained it this way: There is delisting with a "Capital D" and a "lowercase d" the difference is science/data proving that the river has recovered vs. a letter stating that all actions were completed to satisfy delisting requirements
- More information will follow as this discussion continues

Status of the Black River

- Ted Conlin will be speaking with Marcy Kaptur on the status of the Black River, along with representatives from other AOCs
- Since speaking time will be limited, he will draft a document to share with her
