- Fiscal Report
 - Stephanee: We need to spend \$9,804.57 by March 31.
- Old Business
 - Approval of Meeting Minutes 09/16/2021
 - Stephanee: No minutes today. Sorry, next meeting.
 - App updates
 - Ickes: No updates. Meeting with Ed Thursday. We have ordered signposts for QR codes.
 Need Ed to make QR codes before we can send them to the sign company for the actual signs.
 - FireFish project updates
 - Stephanee: Screenshared final Publisher draft that was sent to the artist top half of each panel with photos and information. Waiting to hear from the artist for completion timeline. Don asked if we could possibly get it completed before March 31. Stephanee is hoping so but waiting to hear. No questions from the committee.
- Black River Restoration Project Updates
 - County
 - Don: "It's winter, it's cold, the growing season is definitely over. So, we wait for spring." Submitted final report for Willow Creek. Under contract with Coldwater to do final closeout. Will probably not spend all the funds. We have a history of being under budget for these projects. Last day for grant activity is Feb 22. And then final closeout. Lyn doesn't have all the numbers to share at the moment, but we will post results on webpage and social media.
 - City
 - Risch: (Kate's on vacation & Chip has been out) Cap & cover project is going through closeout with the contractor. Seep project is dealing with cold weather changes. All needs to be finished by June. No questions from committee members.
- Ohio AOC Program Updates
 - Ohio AOC Conference
 - Melanie: Dredge BUI doc is still under review. Holiday setbacks. Comments should come in the next week or 2. Then to the BRAC for comments mid-February, then to public comment by early March. Official removal slated for some time in April. Will keep you updated through next steps. Looking for quick turnaround.

Melanie: Biological BUIs are the next priority – compiling data for last 10+ years; 2012 - present. Evaluated with BUI targets by HUCs per site [Surface Water Quality and Hydrologic Units (HUCs)]. Will send summary page to LY for forwarding. For French Creek, BUIs 3 & 14 meet the target, but #6 does not meet it. Numbers have actually fallen. The main stem has different targets --- all BUIs meet all of the targets. Not meeting targets beyond there. Hoping to do a full sweep of biological sampling in 2023. May push back some BUI removals. If everything goes as planned, looking at delisting by 2025. Risch: Kate will want info. You averaged each site and then averaged the HUC? Were there more sites for one over the other? Melanie can forward all info accordingly. Who will do 2023 sampling? Answer: Not sure but will be contracted out.
