- September 18, 2025: 2 BUIs removed: "Degradation of Fish & Wildlife Populations" & "Loss of Fish & Wildlife Habitat"
 - 1 BUI remains: "Degradation of Benthos" currently under review.

Black River Watershed Project Updates

- o County: Don Romancak
 - Gerber-Beckett project: \$1 million H2Ohio award, \$1 million Save Our Great Lakes award, \$1 million from Beckett Industries, & \$1 million from the County for the 60acre Gerber wetland project. Converts previous ag land into 23 acres of wetlands and more than 1000 linear feet of stream restoration in the Willow Creek watershed.
 - Tour of property with LC Commissioners, Rep. Gayle Manning, Beckett family, & other stakeholders on October 17th.
 - Lorain Port Authority now owns the property.
 - Topsoil & planting to occur remainder of October, as weather permits.
 - Foster Ditch H2Ohio Project in LaGrange, south of the village. Pre-construction meeting this week. Garza Dirtworks provided a good bid of \$640,000 & will have the site done by the end of the year.
 - Kelner Ditch in Lagrange: some areas regraded & seeded. Garza Dirtworks also involved in this project, which is over 5 miles long. This is more of a traditional "ditch project" that is being performed in sections.

o <u>City</u>: Kate Golden

- Geopools did not accept dredge materials this year due to USACE budget constraints.
 Agreement with City will be revised for the city to use dredged materials up to 60,000 cubic yards. The four geopools that were damaged have been replaced. Liners still need to be installed.
- Waterfront redevelopment & brownfield nearly done. Road is paved; electricity, railings, bollards coming soon.
- ODNR grant for fish cleaning station timeline TBD
- Hot Waters: surveyors this week. KMU is the contractor. The in-water work was significantly cut due to budget. Anticipate a spring 2026 start.
- USFWS grant: contract with Great Lakes Demolition Co. for mound construction & tree planting at Rec Site in the next month. This will create habitat & provide a windbreak for the dredge facility.
- St. Joe's & Stoveworks sites are on hold temporarily. The Stoveworks site has lead contamination. A binder mix in soil from the dredge materials to bind to lead & can then be disposed of in a regular landfill. St. Joe's site has asbestos contamination & may receive some soil from the Stoveworks site.
- The City of Lorain public survey has received over 1000 responses.

Ohio AOC Program Updates & Announcements: Hannah Boesinger

- Ohio Lake Erie Commission (OLEC) is working with USFWS on BUI 6 (Degradation of Benthos)
 assessment of the validity of the target across AOC as well as non-AOC lacustuaries. This will
 likely delay final delisting but will provide stronger justification in the removal of the BUI.
 Sampling took place this field season by EnviroScience in the Black, Huron, & Vermilion Rivers.
- OLEC compiling information to prepare for eventual delisting. Needs additional information from the Committee.
 - Hannah requests pictures pre- & post- projects from the Management Action List:
 - Address historic & current sources of pollution; acknowledge all partners in the AOC work.
- AOC Cross Agency Partnership Summit (ACAPS) was held September 16-18 in Toledo, OH.
 Committee members shared their thoughts well organized, great networking. Lots of spotted lanternflies.

- A brief video (<u>Ashtabula example</u>) needs to be made highlighting the Black River's progress.
 John S. agreed to assist. Drone footage might be done by Coldwater Consulting.
 - Reach out to Sea Grant Gay Eyerman did the last video. Hannah has contact info.

Native planting and invasive removal at Margaret Peak Nature Preserve (7.7 acres of Category 3 wetland and 2.2 acres of Category 2 wetland).	2017
French Creek Fish Toxicity Study	Determine cause to fish toxicity issues.	2019

 One large grant up to \$750,000 available. There may be 2-3 more rounds of this grant coming.
- Initiative for Resilient Great Lakes Coasts supports Great Lakes coastal communities to develop nature-based projects that address coastal challenges like erosion and flooding.
- Steve H. reports that Dina Barnhouse is the new chief of the Division of Water Resources with ODNR Coastal Management Program.
